

# THE WISDOM ACADEMY NO PLATFORM POLICY

The Wisdom Academy July 2025

The Wisdom Academy is committed to providing a safe, inclusive, and nurturing educational environment for all pupils, staff, and families. The No Platform Policy establishes clear guidelines for external speakers, visitors, and content that may be presented within our school community.

We believe in fostering critical thinking and age-appropriate discussion while protecting our pupils from harmful ideologies and discriminatory viewpoints that could undermine their wellbeing, safety, or the school's inclusive values.

# Scope

This policy applies to:

- All external speakers invited to address pupils, staff, or parents
- Educational materials and resources brought into the school
- Visiting performers, presenters, and workshop facilitators
- Parent/guardian presentations and contributions
- All school-sponsored events, both on and off-site

# **Principles**

The Wisdom Academy will not provide a platform for individuals or groups who:

## **Promote Discrimination**

- Advocate hatred, prejudice, or discrimination based on race, ethnicity, religion, gender, sexual orientation, disability, or any other protected characteristic (Equalities Act, 2010)
- Promote supremacist ideologies or extremist political movements
- Encourage bullying or harassment of any group

#### Threaten Child Safety

- Promote content inappropriate for primary-aged children (ages 4-11)
- Advocate for harmful practices toward children
- Undermine established safeguarding principles

#### **Undermine Educational and School Values**

- Promote anti-scientific conspiracy theories that contradict established curriculum
- Advocate for the denial of established historical facts
- Promote ideologies that fundamentally contradict the school's commitment to critical thinking and evidence-based learning

# **Decision-Making Process**

#### **Initial Assessment**

All external speakers and content must be approved in advance by the Head Teacher or designated Senior Leadership Team member.

#### **Review Panel**

For potentially controversial speakers or content, a review panel consisting of:

- Head Teacher
- Deputy Head Teacher
- Proprietor
- Designated Safeguarding Lead

#### Consultation

Where appropriate, the school may consult with:

- Birmingham City Council education team
- PTA representatives

# **Alternative Approaches**

When declining a platform request, the school will:

## **Provide Clear Reasoning**

Explain the specific concerns that led to the decision, referencing this policy

### **Suggest Alternatives**

Where possible, recommend alternative speakers or resources that address similar topics in an age-appropriate and inclusive manner

### **Educational Opportunities**

Use declined requests as opportunities to discuss critical thinking, media literacy, and the importance of reliable sources with appropriate audiences

# **Appeals Process**

## **Right of Appeal**

Any decision made under this policy may be appealed within 14 days to the Proprietor in writing

## **Appeal Consideration**

Appeals must be made in writing, stating specific grounds for reconsideration

#### **Final Decision**

The Proprietors decision on appeals is final

# **Monitoring and Review**

#### **Annual Review**

This policy will be reviewed annually by the Headteacher and Proprietor

## **Incident Recording**

All decisions made under this policy will be recorded and reviewed as part of the annual assessment
